## **ORDER**

WHEREAS, this Department had allotted Shack No. 4 at Arambol Beach, Pernem Taluka, to Shri. Manuel Espritosanto Fernandes, r/o Girkarwada, Arambol, Pernem, Goa, vide Shack License No. (SHACKS)/2024-25/GSHN001394 dated 14/08/2024.

AND WHEREAS, this Department has received a report dated 27/01/2025 from the Police Inspector, Mandrem Police Station, wherein it is informed that on 26/01/2025, at 18:45 hrs, an incident occurred over the issue of shifting the chairs which were arranged on the shore of the Arambol beach by the Sea Lounge Beach Shack where the accused were employed and the quarrel escalated and suddenly in the fit of anger, accused persons assaulted the deceased Mr. Amar Bandekar with slaps, kicks and with sharp and hard object causing him serious bodily injuries and to avoid and save himself from further assault. Further, that the deceased managed to escape from the spot and after running few distance, deceased collapsed and when shifted to CHC Tuem in 108 ambulance and upon arrival at the Hospital Medical Officer on duty declared victim as brought dead.

AND WHEREAS, the Police Inspector, Mandrem Police Station, has reported that the said incident occurred at 18.45 hrs on 26/01/2025 near Sea Lounge Beach shack, Arambol, Pernem-Goa and the FIR No. 15/2025 has been registered under section 103 r/w 3(5) of the Bharatiya Nyaya Sanhita, 2023.

AND WHEREAS, the Police Inspector, Mandrem Police Station, has further informed that during the inquiry, it is revealed that the allottee/ licensee of the Shack No.4, namely Shri. Manuel Espritosanto Fernandes, r/o Girkarwada, Arambol, Pernem, Goa, has sublet the said beach shack to Mr. Lalchand, s/o Sriramdas Chauhan, n/o Village Urtoo, District Kullu, Himachal Pradesh.

AND WHEREAS, it is further stated in the said letter that Manuel Espritosanto Fernandes shack allottee No.4 at Arambol beach stretch has sublet the beach shack to Mr. Lalchand S/o Sriramdas Chauhan native of village-Urtoo, Dist-Kullu, Himachal Pradesh. The Police Inspector of Mandrem Police Station has further requested to cancel the Shack License No. (SHACKS)/2024-25/GSHN001394 dated 14/08/2024.

AND WHEREAS, the Goa State Shack Policy for Erection of Temporary Seasonal Structures, Beach Shacks, Deck Beds/ Umbrellas, For Tourist Season 2023-26 (3 years) in Clause 20 "Breach of Terms under this Policy and associated Penalties for Beach Shacks", lays down penalty for sub-lease of Beach Shacks.

AND WHEREAS, upon examining the report dated 27/01/2025 from the Police Inspector, Mandrem Police Station, the undersigned is satisfied that this is a fit case for imposing the penalties as laid down in Clause 20 of the Goa State Shack Policy for Erection of Temporary Seasonal Structures, Beach Shacks, Deck Beds/ Umbrellas, For Tourist Season 2023-26 (3 years), since it is evident that Manuel Espritosanto Fernandes shack allottee No.4 at Arambol beach stretch, has sublet the beach shack.

Therefore, I, hereby pass the following Order:

- 1. A penalty of Rs.25,00,000/- shall be imposed on Shri. Manuel Espritosanto Fernandes, r/o Girkarwada, Arambol, Pernem, Goa, allottee of Shack No. 4 at Arambol Beach Stretch.
- The Security Deposit paid by Shri. Manuel Espritosanto Fernandes, r/o Girkarwada, Arambol, Pernem, Goa, shall be forfeited to the Government Treasury.
- 3. The Shack License issued to Shri. Manuel Espritosanto Fernandes, r/o Girkarwada, Arambol, Pernem, Goa, stands cancelled.
- 4. The erected Beach Shack No. 4 shall be demolished by Shri. Manuel Espritosanto Fernandes within 7 days from the date of receipt of this Order, failing which the said beach shack shall be demolished by this Department at the cost and risk of the beach shack allottee and the cost of such removal shall also be recovered from the beach shack allottee by way of demands of arrears of Land Revenue.
- 5. Shri. Manuel Espritosanto Fernandes, r/o Girkarwada, Arambol, Pernem, Goa, is permanently blacklisted and shall be debarred from participating in the Tourism Shack Policy to be formulated by the Department of Tourism in future.
